6.0 School Report	 <u>6.1 High school re-design:</u> School leadership is looking at the AB education redesign program with an eye to modernizing high schools. The focus will be on students. Looking for more flexibility, teacher advisory group, advocacy, etc. ? change funding structure to 'per student' rather than 'per credit'. Staff will discuss and report back. <u>6.2 grade 9 special meeting with SRO:</u> The grade 9 class received special education on behaviour in light of reports of violence by several boys against a group of girls. Sean Reader and SRO Janice Schoepp talked to the boys about correct mature male behaviour. The school will report to City council about the positive impact of having the SRO. <u>6.3. Other Initiatives</u>: Looking at Post secondary credits in high school, mostly in the trades. Staff is discussing concerns about crowding next year and creative solutions. Also, AP program is under review. There are both positive and negative aspects. <u>6.4 New Staff</u>: Colin Elko (0.85 FTE) will be teaching Construction and Social. He was a NAIT instructor, journeyman electrician, M.Ed. <u>6.5 Grad</u>: Meeting for grad parents will be held separately this year.
